# IN MEMORIAM

## Pete Snider

Sometimes we forget: we stand on the shoulders of giants.

SAM has lost a very dear friend and an industry giant. Pete Snider passed away on February 15, 2025, and he will be sorely missed.

Pete was destined, from an early age, to be in this business. Trained as an architect, Pete specialized in building envelope and glazing systems. In the course of his career, he secured several patents for innovative new designs.

Pete was one of us - he acquired commercial glazing contractor, Alco Glass, Inc., and operated it until he retired in 2012. More than that, however, Pete was devoted to the success of the industry and promoting the interests of subcontractors through education and a more than a little activism. After serving in leadership positions in the ASA's Dallas chapter, Pete was instrumental in the founding of the Subcontractors Association of the Metroplex in 1992. During his tenure with SAM, Pete served as Director and Officer (in several roles).

Pete continued his dedication to the industry and to SAM when, following his retirement from Alco Glass, he took on the new job of Executive Director for SAM. In this role, Pete had a steady hand on the tiller and continued his devotion or dedication to the industry. Pete was instrumental in SAM's involvement in the National Subcontractors Alliance, instituting conducting the first meetings with NSA's leadership. In this endeavor, Pete carried forward the legacy and mission of Norma Mann, with whom he was a life-long friend.

Pete's public spirit was hardly limited to the construction industry; he was, for most of his adult life, a committed member of Rotary International, advancing to the critical position of District Governor of Rotary's District 5810. Pete continued his Rotary service by conducting President Elect Training Seminars for newly-elected Rotary club presidents, passing along his wealth of wisdom and experience.

Pete is survived by his devoted wife, Sherry, his son Paul, grandchildren and devoted friends. He leaves behind a void which can never be truly filled.

# SAFETY CORNER

## March Safety Tips

### Preventing Slips, Trips, and Falls

Wet and icy conditions in February can lead to increased risks of slips, trips, and falls, both indoors and outdoors. Businesses should prioritize clearing walkways, using non-slip mats, and encouraging employees to wear appropriate footwear. Regular inspections of floors, stairways, and entry points can help identify potential hazards. Ensuring prompt spill cleanup and clearly marking wet areas are simple but effective strategies to mitigate accidents.

### Electrical Safety Awareness

With winter heating and lighting demands, electrical safety becomes critical. February is an excellent time to train employees on identifying and reporting electrical hazards, such as exposed wires and overloaded outlets. Employers should schedule routine checks for electrical systems and ensure all equipment is up to code. Providing personal protective equipment (PPE) for employees working on electrical systems and enforcing lockout/tagout procedures can significantly reduce risks.

### Cultivating a Safety Culture

A strong safety culture is a cornerstone of workplace safety. February is an ideal month to reinforce this by engaging employees in safety discussions, recognizing safe behaviors, and fostering a sense of shared responsibility. Leadership must set the tone by prioritizing safety in every aspect of operations, from risk evaluations to daily routines. Empowering employees to report concerns without fear of reprisal encourages a proactive approach to safety.

### Sleep Deprivation

Time changes impact employees across the board. Decreases in alertness, reaction time, and decision-making ability have the potential to affect our health and safety and the health and safety of those around us while at work, on the road, or at home.

# SAFETY CORNER

## Ladder Safety Month

Fall protection consistently rises to the top of OSHA's most frequent citations. This is why Ladder Safety Month is so important; it gives us an opportunity to check in on safety procedures and ensure our workforce is up to date as well. We recommend you take some time to revisit ladder safety training and recheck existing workplace ladders to ensure they are still up to date with OSHA's current requirements.

### Why is fall protection important?

Falls are among the most common causes of serious work related injuries and deaths. Employers must set up the work place to prevent employees from falling off of overhead platforms, elevated work stations or into holes in the floor and walls.

What can be done to reduce falls?

Employers must set up the work place to prevent employees from falling off of overhead platforms, elevated work stations or into holes in the floor and walls. OSHA requires that fall protection be provided at elevations of four feet in general industry workplaces, five feet in shipyards, six feet in the construction industry and eight feet in longshoring operations. In addition, OSHA requires that fall protection be provided when working over dangerous equipment and machinery, regardless of the fall distance.

To prevent employees from being injured from falls, employers must:

- Guard every floor hole into which a worker can accidentally walk (using a railing and toe-board or a floor hole cover).
- Provide a guard rail and toe-board around every elevated open sided platform, floor or runway.
- Regardless of height, if a worker can fall into or onto dangerous machines or equipment (such as a vat of acid or a conveyor belt) employers must provide guardrails and toe-boards to prevent workers from falling and getting injured.
- Other means of fall protection that may be required on certain jobs include safety harness and line, safety nets, stair railings and hand rails.

OSHA requires employers to:

- Provide working conditions that are free of known dangers.
- Keep floors in work areas in a clean and, so far as possible, a dry condition.
- Select and provide required personal protective equipment at no cost to workers.
- Train workers about job hazards in a language that they can understand.



## 2025 Design + Build Competition

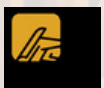
SAM partnered with the Construction Industry Education Foundation (CIEF) about two years ago. In that short time, two SAM Board Members, Becca Neu and Josue Garay, along with Executive Director Carrie Buckley, have been involved with the planning and implementation of two important industry events: Trades Day Expo and the upcoming Design + Build Competition on May 7-8 at Cedar Valley College in Lancaster.

The Design + Build Competition allows high school students to build a structure for their community while industry professionals mentor them through the process. Students drive the entire process beginning with the design process with the help of their instructors and a team sponsor to the complete building process.

On May 7, students will build their structures. This is an all day event which relies heavily on in-kind donations from the industry. Team sponsors and volunteers oversee the construction to ensure students are working safely.

On May 8, industry professionals are invited to attend the Industry Lunch free of charge. This provides the students an opportunity to begin to build their network for the next chapter in life. After the Industry Lunch is an Awards Ceremony which includes scholarships for students. SAM is proud to support CIEF in its mission to connect high school students with industry professionals.

Teams are encouraged to build with a purpose and donate their structures to local nonprofits or sell them to fund a worthwhile cause in their community.

### ARCHITECTURAL MENTORS

Support the students while they design their preliminary plans, either in-person or virtually for a maximum of two hours.



### PRELIMINARY PLAN REVIEWERS

You receive two or three sets of plans to review and provide feedback to the schools. This can take a couple hours in the month of February.



### JUDGES

Join on the second day of the competition to walk the job sites and score each team's structure. This takes place after the Industry Lunch (12 PM - 1 PM) and can take a few hours to complete.



### IN-KIND MATERIALS

Ask about the materials needed for the competition and provide in-kind donations or materials at cost.



### TEAM SPONSOR

Engage with a school by sponsoring their team. This includes signage on team structure, logo on t-shirts, team photo with logo, opportunity to visit and interact with student team prior to the competition.

# LEGAL MINUTE

## Corporate Transparency Act - Off Again, for Good?

The Corporate Transparency Act, legislation which required business entities like corporations or limited liability companies to disclose the identity of beneficial owners in filings with the Treasury Department and exacted significant financial penalties for the failure to report, or to report on-time, has been a real hot potato. As soon as it was passed, the law was subjected to legal challenges, enforcement was enjoined by courts, then (most recently) the injunctions against enforcement were lifted.

The latest shoe to drop (is this thing a centipede?) came in an announcement by the Treasury Department on March 2, 2025 (found at <https://home.treasury.gov/news/press-releases/sb0038> ). The Treasury Department announced that, not only was it not going to enforce any penalties or fines associated with non-filing or late filing of beneficial ownership information reports under the existing regulatory deadlines, but further that, as a matter of policy, Treasury was not going to enforce any penalties or fines against United States citizens or domestic reporting companies or their beneficial owners after forthcoming rule changes take place.

In a significant narrowing of scope, the Treasury Department has announced that it will be issuing proposed rulemaking to limit the rule to applying to foreign reporting companies only. According to the Treasury Department's Press Release, "Treasury takes the step in the interest of supporting hard-working American taxpayers and small businesses and ensuring that the rule is appropriately tailored to advanced the public interest."

For those of you who have already filed your Beneficial Ownership Interest reports, this should be no harm in having filed; the content of these reports is not publicly available. But for those of you who have been waiting to see how the legal and political wrangling over the law would play out, it appears that, for non-foreign entities, no further action on your part is required.

Unless they change their minds, again!
